


The answer to this question depends in large part on not only the facts and circumstances of the particular accident, but also on the state in which you live. Many states require you to report any accident that involves an injury. Even for accidents involving only vehicle damage, some states still require drivers to report the accident scene one of the most important things to do is to exchange contact information with the other driver and to also obtain the other driver's insurance information. Every state requires drivers to exchange this kind of information if they have been involved in an accident. If the other driver does not have insurance, you should request the involvement of law enforcement at the accident scene to help you obtain this information. Depending on the location of the accident, the law enforcement agency might be municipal police, county sheriff, or the highway patrol. Even if the other driver about the cause of the accident. This will give the investigating officer an opportunity to record the circumstances of any physical evidence at the scene, such as skid marks or debris.
